(a) Golden Landmark Pte Ltd has a direct interest in 191,806,000 Stapled Securities. F.E. Holdings Pte Ltd has a controlling interest in Golden Landmark Pte Ltd. PN has a more than 20% interest in F.E. Holdings Pte Ltd and is therefore deemed to be interested in the 191,806,000 Stapled Securities in which Golden Landmark Pte Ltd has an interest.


(b) Riverland Pte Ltd has a direct interest in 80,294,000 Stapled Securities. F.E. Holdings Pte Ltd has a controlling interest in Victory Realty Co Private Ltd, which in turn has a controlling interest in Riverland Pte Ltd. PN has a more than 20% interest in F.E.
