RN is a beneficiary of the Estate and is therefore deemed to be interested in the 185,156,025 Stapled Securities in which Far East Organization Centre Pte. Ltd. has an interest.

(b) Golden Development Private Limited has a direct interest in 411,408,546 Stapled Securities. The Estate has a controlling interest in Golden Development Private Limited.
