RN is a beneficiary of the Estate and is therefore deemed to be interested in the 196,396,847 Stapled Securities in which Far East Organization Centre Pte. Ltd. has an interest.

(b) Golden Development Private Limited has a direct interest in 446,255,963 Stapled Securities. The Estate has a controlling interest in Golden Development Private Limited. RN is a beneficiary of the Estate and is therefore deemed to be interested in the 446,255,963 Stapled Securities in which Golden Development Private Limited has an interest.
