12. Remarks (if any):

A. On 28 April 2021, a total of 5,337,000 stapled securities in Far East Hospitality Trust ("Far East H-Trust"), each stapled security comprising one unit in Far East Hospitality Real Estate Investment Trust ("Far East H-REIT") and one unit in Far East Hospitality Business Trust ("Far East H-BT") have been credited to the accounts of FEO Hospitality Asset Management Pte. Ltd. (the "REIT Manager"), as manager of Far East H-REIT, for the payment of management fees as follows:-

(i) 2,566,996 stapled securities in Far East H-Trust at an issue price of approximately S\$0.6235 per stapled security as payment of base management fee for the quarter ended 31 March 2021; and

(ii) 2,770,004 stapled securities in Far East H-Trust at an issue price of approximately S\$0.6197 per stapled security as payment of performance management fee for the financial year ended 31 December 2020.

The issue price per stapled security was based on the volume weighted average price for a stapled security for all trades on the Singapore Exchange Securities Trading Limited for the last ten (10) business days of the relevant period in which the fees accrue.

The REIT Manager has elected to receive 90% of its management fees in stapled securities in Far East H-Trust for the financial year ended 2020 and for the quarter ended 31 March 2021.

With the above-mentioned issue of new stapled securities, the REIT Manager holds an aggregate of 106,902,234 or 5.43% of Far East H-Trust stapled securities and the total number of Far East H-Trust stapled securities in issue is 1,969,458,374 as at the date of this announcement.

B. The percentage before and after the change was computed based on 1,964,121,374 stapled securities in issue as at 22 April 2021 and 1,969,458,374 stapled securities in issue as at the date of this announcement respectively.
