CHANGE IN COMPOSITION OF BOARD COMMITTEES

FEO Hospitality Asset Management Pte. Ltd. (the "REIT Manager"), as manager of Far East Hospitality Real Estate Investment Trust ("Far East H-REIT"), and FEO Hospitality Trust Management Pte. Ltd. (the "Trustee-Manager"), as trustee-manager of Far East Hospitality Business Trust ("Far East H-BT") (collectively, the "Managers"), wish to announce the following changes in the Board Committee of the REIT Manager with effect from 1 August 2025:

1. Consolidation of Board Committees

The Nominating Committee ("NC") and the Remuneration Committee ("RC") will be consolidated into a single committee as the Nominating and Remuneration Committee ("NRC"). This consolidation aims to enhance operational efficiency in overseeing the nomination, performance evaluation, and remuneration of Directors and Key Executives, and to streamline the responsibilities previously undertaken separately by the NC and the RC.

2. Cessation of Lead Independent Director Role

Ms. Vivienne Lim Hui Bian will step down as Lead Independent Director ("Lead ID"), as the Chairman of the Board is now independent and the Lead ID role is no longer required.

3. New Composition of Board Committees
